Material Information/Transactions

On 21 November 2018, LBC Express Holdings, Inc. (the "Company") was advised by LBC Express, Inc. that its director, Fernando G. Araneta, received a letter from the Bangko Sentral ng Pilipinas ("BSP") regarding the approval by the Monetary Board of a resolution temporarily disqualifying Mr. Araneta from becoming a director and/or officer in any BSP-supervised financial institution.

This disqualification stems from the closure of LBC Development Bank, Inc. ("Bank") wherein Mr. Araneta was a director.

The involvement of Mr. Araneta, if any, in the closure and the acts that led to the same is currently being evaluated by the BSP. Pending completion of such evaluation, it appears that the BSP has imposed such temporary disqualification.

The Company is seeking more information and clarity on details of the said Monetary Board resolution and will continue to comply with the PSE's disclosure requirements.
