Gentlemen:

We refer to your letter dated May 14, 2015 (the "Letter") relating to the compliance by Federal Resources Investment Group, Inc. ("Company") with the website template for publicly-listed companies pursuant to SEC Memorandum Circular Nos. 11 and 18, Series of 2014 (the "SEC Circulars"), which Letter was received by the Company on June 9, 2015.

In said Letter, the Company was directed to show cause within five (5) days from receipt thereof why it should not be held liable for failure to comply with the following requirements of the SEC Circulars by the December 31, 2014 deadline: (i) provide information or data in the Company's website on the Company's conglomerate map or group corporate structure; and (ii) provide information or data in the Company's website on press materials/news.

In compliance with the Commission's directive, our explanation follows.

- 1. On the Conglomerate Map/Group Corporate Structure We note that in the *Home>Our Company* page (http://www.federalresourcesinv.com/index.php/home/ourcompany) of the Company's website, there is a section on "Conglomerate Map", which contained the note "N/A" since the Company currently has no parent company nor subsidiaries and affiliates.
- 2. On the Press Materials/News There is a page on "Press Materials/News" (http://www.federalresourcesinv.com/index.php/press-materials-news), which did not, however, contain any information and has not been updated considering that the Company did not make any press releases nor provide any materials in briefings to analysts and the media.

We hope that you will find the foregoing explanation satisfactory.
