#### Background/Description of the Disclosure

On 10 July 2017, the Board of Directors of LBC Express Holdings, Inc. (the "Company") resolved to approve the refiling with the Securities and Exchange Commission ("SEC") of the Company's Registration Statement in relation to the public offering by the Company (the "Follow-on Offering") of up to 69,101,000 common shares (the "Offer Shares"), consisting of 10,000,000 new common shares to be issued and offered by the Company by way of a primary offer and of 59,101,000 existing common shares to be offered by selling shareholders pursuant to a secondary offer. The indicative offer price for the Follow-on Offering is up to Php22.00 per share. Philippine Commercial Capital, Inc. is the lead underwriter and issue manager for the Follow-on Offering.

The Company expects to use the net proceeds from the offering for general corporate purposes and working capital, including the expansion of retail and corporate business, information technology development, and other corporate purposes.
