Replacement security for the USD50 million Convertible Instrument due 2024 (the "Instrument") issued by the Company on 4 August 2017

### Background/Description of the Disclosure

### Background

On 4 August 2017, the Company issued the Instrument in favor of CP Briks Pte Ltd ("CP Briks"). Simultaneous with the issuance of the Instrument, LBC Development Corporation ("LBCDEV"), the parent of the Company, extended a third-party pledge in favor of CP Briks (the "Initial Security") over 51% of the outstanding capital stock of the Company owned and held by LBCDEV (the "LBCDEV Pledged Shares") to secure the obligations of the Company under the Instrument. The Initial Security was extended pending approval by the shareholders of the Company of the pledge over all of the Company's shares in LBC Express, Inc.

On 29 August 2017, the shareholders of the Company approved (i) the issuance of the Instrument in favor of CP Briks and (ii) the constitution of a pledge over all of the Company's shares in LBC Express, Inc in favor of CP Briks.

### Replacement Security

The Company entered into a pledge supplement dated as of 3 October 2017 with CP Briks, whereby the Company constituted in favor of CP Briks a pledge over all of the Company's shares in LBC Express, Inc. ("LBC Express") or a total of 1,041,180,504 common shares of LBC Express (the "Replacement Security"). The Replacement Security shall serve as security for the obligations of the Company under the Instrument upon satisfaction of the conditions for the effectivity of the said Replacement Security.

Immediately upon the satisfaction of the conditions for the effectivity of the Replacement Security, the Initial Security shall automatically terminate and the lien over the LBCDEV Pledged Shares shall automatically be discharged.
